## CIRCULAR LETTER TO ALL MEMBER COMPANIES

Re: Transportation Network Companies

Insurance Services Office, Inc. (ISO) has filed and received approval from the North Carolina Department of Insurance (Department) for revisions made to ISO endorsement PP 55 45, Limited Transportation Network Driver Coverage (No Passenger) – North Carolina. ISO has not filed these materials on behalf of the Rate Bureau or any insurer. Recall that coverage for the public or livery conveyance of passengers is not within the jurisdiction of the Rate Bureau (please refer to North Carolina Rate Bureau Circular Letter To All Member Companies A-16-2). However, ISO has granted the Rate Bureau a non-exclusive license to make this endorsement available to member companies of the Rate Bureau solely for use within the state of North Carolina and otherwise in accordance with the license granted under the agreement between ISO and the Rate Bureau. In that regard, please see the attached revised endorsement PP 55 45 06 21, Limited Transportation Network Driver Coverage (No Passenger) – North Carolina.

PP 55 45 06 21, Limited Transportation Network Driver Coverage (No Passenger) – North Carolina may be used by Rate Bureau member companies as filed by ISO or amended as necessary by the individual member company. If a member company adopts the ISO endorsement as filed, the member company should notify the Department of the company's intent to adopt. If a member company modifies the ISO endorsement, a filing must be made with the Department for prior approval. In all correspondence with the Department regarding this filing, companies should refer to ISO Filing Designation Number PP-2020-OTNF1. Furthermore, companies have the option to use other endorsements and/or rules for such coverages; companies desiring to do so must make appropriate submissions to the Department.

Please note that the North Carolina Reinsurance Facility (Facility) has adopted endorsement PP 55 45 06 21, Limited Transportation Network Driver Coverage (No Passenger) – North Carolina as the <u>only</u> TNC endorsement to be used with a Personal Auto Policy that is ceded to the Facility; see Facility Circular Letter To All Member Companies RF-20-28. Regardless of what policy form a member company chooses to use in the voluntary market, the company is required to use endorsement PP 55 45 06 21 and the associated manual rule for any policy ceded to the Facility.

Subject to the above, Rate Bureau member companies should note the following required copyright with respect to the ISO materials:

- Where the ISO copyrighted material is reprinted, copied or otherwise used in full, copies must reflect the copyright notice actually shown on the Product(s).
- Where the ISO copyrighted material is reprinted, copied or otherwise used in part, the following legend must appear at the bottom of each page so used: "Includes copyrighted material of Insurance Services Office, Inc. with its permission."

As noted above, the ISO endorsement has been filed and approved for use as described herein and is available for use as described herein. This revised form was filed by ISO to be used on or after June 1, 2021.

Please note that ISO has not filed any revisions to the corresponding manual rule which was introduced under ISO Filing Designation Number PP -2015-RTNRU.

As noted, this circular pertains to transportation network companies and the public or livery conveyance of passengers. Delivery services (the public or livery conveyance of food, goods, items, or products) are addressed separately; see Rate Bureau Circular Letter To All Member Companies A-20-2.

Please see to it that this circular is brought to the attention of all interested personnel in your company.
