### CIRCULAR LETTR TO ALL MEMBER COMPANIES

Re: Twenty-Eighth Annual Meeting October 25, 2005

The Twenty-Eighth Annual Meeting of the North Carolina Rate Bureau will convene at 8:30 a.m. on Tuesday, October 25, 2005. The meeting will be held at the Grandover Resort and Conference Center, One Thousand Club Road, Greensboro, North Carolina 27407.

Immediately following adjournment of the Twenty-Eighth Annual Meeting, a meeting of the Governing Committee will convene. The agenda for this meeting will be distributed shortly.

The following constitutes the agenda for the Annual Meeting:

### 1. The Annual Report

The Twenty-Eighth Annual Report will be presented.

### 2. 2004 Annual Meeting Clarification

At the last Annual Meeting, in addition to selecting members to the Governing Committee to replace those members ineligible to serve an additional term, a replacement for Governing Committee member St. Paul Fire and Marine Insurance Company, because of a merger, was necessary.

Unfortunately, it was not clear in the voting process which of the two stock companies was elected to take St. Paul's place. This is significant, since St. Paul's term expires this year, and therefore the company elected to serve the remainder of St. Paul's unexpired term will have to stand for election this year to a full three year term.

A vote of members will be necessary to determine which of Cincinnati Insurance Company and Progressive Insurance Company was elected to serve out St. Paul's unexpired term and which was elected to a three year term.

### 3. Governing Committee Election

The Rate Bureau's Constitution provides that the Governing Committee shall be composed of six stock company members, six non-stock company members and two non-voting public members appointed by the Governor. With respect to the company members the Constitution provides that at least one member of the Governing Committee shall be a company domiciled in North Carolina, and that at each Annual Meeting the scheduled vacancies occurring in the Governing Committee shall be filled by the election of two stock and two non-stock companies to serve for terms of three years.

It will be in order to elect two stock and two non-stock members for three year terms to expire in 2008. The Constitution provides that no member shall be eligible to serve consecutively more than two three year terms as a member of the Governing Committee. Of the four companies whose terms expire this year, only State Farm will not be eligible for re-election since only that company will be completing a second successive three year term.

The Chairman of the Governing Committee has appointed a Nominating Committee, and the report of that Committee will be presented.

# 3. Any other business which might properly come before the meeting.

We urge that you have a representative of your company in attendance at this meeting. For those companies that cannot be represented, voting by proxy is permitted. A proxy form is enclosed which we request you complete and forward as soon as possible, but no later than September 20, 2005, whether or not your company expects to be represented in person. This will help assure a quorum is present. If a representative of your company is present at the meeting, the proxy will not be used. It is suggested that member companies consider naming as proxy one of the twelve current company members of the Governing Committee.

# **DESCRIPTION**

# GRANDOVER RESORT & CONFERENCE CENTER AIRPORT TRANSPORTATION

Grandover Resort & Conference Center is pleased to offer airport transportation to and from Piedmont Triad International Airport for our hotel guests. If you desire to use this service for your guests, please note the following information:

- 1. Arrangements may be made by advance reservation, or by calling the resort on the courtesy phone located in the baggage claim area at the airport.
- 2. A charge of \$15 per passenger round trip <u>or</u> one way will apply. Please instruct whether the group or the individual will be responsible for this payment. Charges will be placed on the group master bill or individual room folios as per your instruction.
- 3. In general the shuttle schedule is: Departure from hotel lobby at the top of every hour and half-hour. Pick up at the airport quarter past every hour and three quarters past every hour.
- 4. If you will arrange shuttle service for your guests, please submit the transportation manifest to the resort no later than 7 working days prior to arrival. Manifests should include the date of arrival/departure, flight number, flight time, name of passenger.
- 5. Upon arrival to the airport, guests will find the Grandover vehicle OUTSIDE baggage claim. Due to airport regulations, our driver is not able to leave the vehicle and enter into the airport terminal. Please advise your guests that if their flight arrives later than expected, they should use the courtesy phone located in the baggage claim area to call the resort and advise of their arrival.
- 6. In order to accommodate the maximum number of guests, passengers may experience a waiting time prior to departure from the airport. The maximum waiting time for passengers once they have arrived is 30 minutes.
- 7. It is imperative that any changes to manifests be communicated to the Front Desk/Bell Stand immediately. The Resort will do its best to accommodate changes, however, the resort can not guarantee last minute changes will be accommodated due to existing reservations.
