Re: Revised Homeowners Wind Mitigation Credits

On March 8, 2013, the Rate Bureau announced revisions to the wind mitigation credits contained in the Homeowners Manual. It has been noted that there is an error in the approved credits. In that regard, please find enclosed corrected wind mitigation credits that reflect these changes.

The approved changes are to be implemented in accordance with the following Rule of Application:

These changes are applicable to all new and renewal policies becoming effective on or after July 1, 2013.
